ARTIST-GALLERY CONTRACT

AGREEMENT made as of September 1, 2021 between Hunter Biden (hereinafter referred to as the "Artist"), and Georges Bergès Galleries, LLC (hereinafter referred to as the "Gallery"), located at 462 West Broadway, New York, NY 10012.

WHEREAS, the Artist is a professional artist of good standing; and

WHEREAS, the Artist wishes to have artworks represented by the Gallery, and

WHEREAS, the Gallery wishes to represent the Artist under the terms and conditions of this Agreement.

NOW, THEREFORE, in consideration of the foregoing premises and the mutual covenants hereinafter set forth and other valuable consideration, the parties hereto agree as follows:

1. **Scope of Agency.** The artist appoints the Gallery to act as Artist's exclusive agent for the exhibition and sales of all his artwork worldwide. ~~Artworks include but not limited to lithographs, other visual art, digital art and digital NFT products.~~ Gallery shall provide artist with two solo show exhibitions during the term of this agreement. Gallery shall maintain insurance for artworks in its possession.

2. **Term and Termination.** This agreement shall have a term of twenty-four (24) months and may be further extended by agreement or terminated, ^{at any time} by either party upon giving ³⁰ (30) days written notice to the other. On termination of the Agreement, unsold artwork in the possession of the Gallery will be returned to Artist, at Artist's direction and expense.

3. **Commissions.** Gallery shall receive a commission of 40% of any and all sales. The Gallery will pay all funds due to the Artist under this agreement within 30 days of the date of receipt of funds from a Purchaser. Works done on a commissioned basis by the Artist, arranged by gallery, shall be considered gallery sales on which the Gallery shall be entitled to a commission. In the event that work does not sell, gallery will return work unframed. Gallery will cover insurance and shipping. ~~For the avoidance of doubt, all sales of Artist's artwork during the term of this agreement and until terminated per the terms of this Agreement shall proceed only through the Gallery and Gallery shall be entitled to a commission as outlined above.~~

4. **Prices/Buyers.** Gallery shall set all sales prices based on its best professional judgment, and the Gallery shall not be required to sell any work at a price it deems inconsistent with a good faith, reasonable assessment of its value in the market. Gallery will not disclose the name of any Buyer(s) of Artist's Artwork to Artist or any agent of artist.

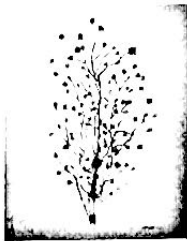

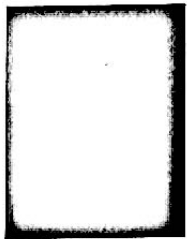
